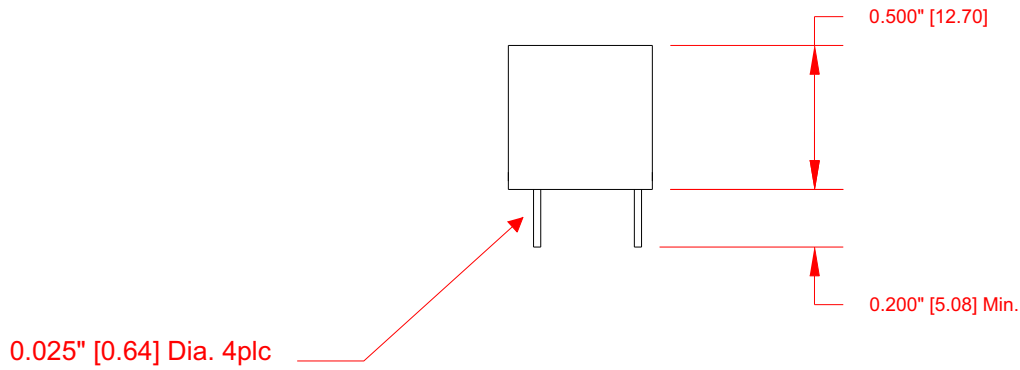
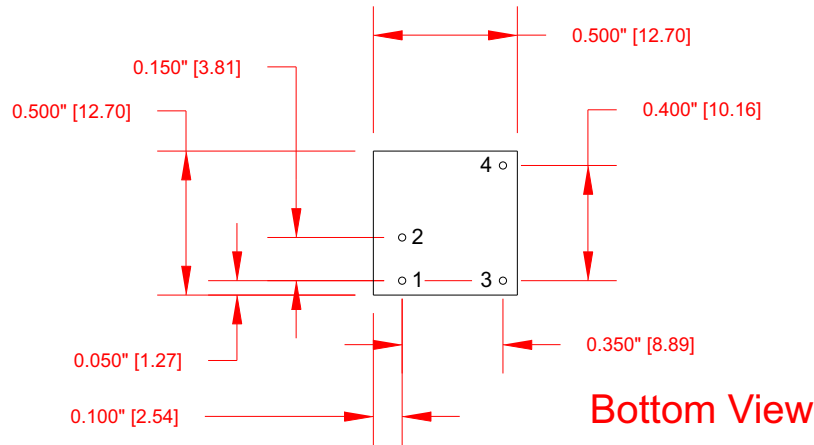

CLEANING AGENTS

Basic Insulation is provided between input and output. To comply with safety agencies requirements, an input line fuse (0.5A SB) must be used external to the converter.

If one input fuse is used for a group of modules, the maximum fuse rating should not exceed 5A.
